

Entry is made for each dog (three separate entry forms) and all entries submitted together. Class is judged on the merits of all three generations entered. For the Generations Class, 35% of the entry fee will be retained by the Club for expenses. The remainder will be divided as follows:

#### "Special Event"

**Best Bred by Exhibitor entered in National Specialty:** Following the award of Best of Breed the winners of the Bred by Exhibitor Puppy and Adult Classes in each sex, will return to the ring. The judge will then select the Best Bred by Exhibitor entered in the specialty. The winner will receive a certificate for "One free Litter Registration offered by AKC"

**Best Feature Competition:** Based on the Norwegian Elkhound Breed Standard, judging by selected breeders, judges, and breed mentors. All Norwegian Elkhounds (altered, veteran, rescue, etc.), at least 6 months of age, are eligible to enter competition; entry fee is \$5.00. Awards: Best Feature and Reserve Best Feature for each feature. A dog may be entered in one or more or all categories, each category limited entry. ## JUNIOR SHOWMANSHIP Novice, Open, Master & Best Junior

**Novice Class:** This shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show and who at the time entries close have not won three (3) first place awards, with competition present, in a Novice Class. A first place in Novice without competition leading to a Best Junior award with competition would count as one win towards moving to Open at a licensed or member show. Junior Handlers who win a third Novice Class with competition, if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open, after the closing of entries for a show are required to transfer their entry from the Novice Class to the Open Class by notifying the Superintendent or Show Secretary prior to the judging of the class at the show.

**Open Class:** This class shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show, and who have won three first place awards in a Novice Class or if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open in a licensed or member show.

**Master Class:** This class will be for boys and girls who are at least 9 years old and under 18 years on the day of the show, and who have won the 10 Best Junior wins with competition. The calendar for this class will be consistent with the eligibility dates for the AKC National Championship. All Juniors meeting the criteria for this class are required to enter the Master Class and must change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to complete for the following year.

Junior handlers must include their AKC Junior Handler Number on each entry form and ensure all information on the <u>front</u> and <u>back</u> of the entry form has been provided, otherwise the entry will not be accepted. Dogs entered in Junior Showmanship may have Full or Limited AKC registration or a PAL/ILP number. Altered animals are eligible for competition; <u>bitches in season are not eligible</u>. 

#### Class Changes Effective January 1, 2020

Entering a Mixture of Regular and Preferred Classes Within the Same Trial Weekend – Multiple Jump Heights Within the Same Trial Day

**Effective January 1, 2020**, exhibitors may enter a mixture of both Regular and Preferred classes on the same trial day and/or during a trial weekend. **Any mixture of Regular and Preferred classes is allowed.** Please note that if a dog qualifies in Regular Master Standard and Preferred Master JWW (or vice versa) on the same trial day, **then NO Double Q shall be earned toward either the MACH or PACH title**. The Double Q still requires that Standard Agility and Jumpers with Weaves be either both Regular OR both Preferred on the same trial day.

Additionally, within the same Regular or Preferred classes, a dog may now be entered in multiple jump heights within the same trial day. For example, the same dog may now be entered in 20-inch Master STD/JWW while also entered in 24C-inch Premier STD/JWW on the same trial day.

A separate entry form must be submitted when the same dog is being entered in a mixture of Regular and Preferred and/or different jump heights within the same trial weekend thereby clearly indicating which class(es) and/or jump heights belong together for each trial day of the weekend.

By entering these trials, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their Norwegian Elkhounds are familiar with and able to perform all obstacles safely. Except for dogs needing measurement, dogs are not required to be at the trial until their scheduled time of judging. The owner/handler of each dog is solely responsible for having it ready at ringside when the class is to be judged.

#### Regular Agility Classes (dogs MAY enter a higher jump height):

16 Inches — Dogs 18" and Under 24 Inches — Dogs Over 22"

#### **Entering For Exhibition Only (FEO)**

#### **Entering For Exhibition Only (FEO)**

- For Exhibition Only may be offered at the option of the host club. FEO will allow exhibitors to work with their dogs in a trial environment. FEO is only allowed in the Time 2 Beat and FAST classes Participation in FEO is non-qualifying.
- FEO runs are treated as trial entries. The exhibitor must enter the class(es) (T2B and/or FAST) prior to the closing date, pay class entry fees and the Trial Secretary must record the entry in the Trial Catalog as part of the results for that class. FEO does not need to be noted on the entry form; the handler will declare the day of the show.
- Dogs may be entered in any jump height for FEO runs. If entered in an ineligible jump height, the team is committed to FEO for that run and must declare FEO on the start line. Day of show jump height changes are not allowed.
- Dogs may be entered in any level of FAST (Novice, Open, Excellent, Master). If the dog is not eligible for the level entered, the team is committed to FEO for that run and must declare FEO on the start line. Day of show level changes are not allowed.
- The exhibitor must declare FEO in the ring prior to leading out to the scribe and the judge.

#### Fix and Go On (FNG)

- Fix and Go On is not pre-entered; rather, it occurs during the course of the run.
- FNG allows exhibitors to immediately reattempt an obstacle at any time while on course when the dog's performance of an obstacle is not to their expectation. This allows the dog to successfully complete the obstacle then finish the course or leave the ring on a positive note. Using FNG will result in a non-qualifying score.

#### **Acceptance of Entries**

First received (entries accepted in order of receipt); 125 run limit for this trial. Agility classes will run indoors on artificial turf; electronic timing and rubberized contacts will be used. Agility entries **OPEN** at 8:00 am CT, Wednesday, Feb. 28,2024. Agility entries **CLOSE** at 6:00 pm CT, Wednesday, April 17, 2024, at the Trial Secretary's office.

#### **Jump Height Card**

Owners are responsible for entering their dog in the proper jump height class. All dogs participating in these trials must have an AKC Jump Height Card or check the box on the entry form to place your dog on the Measuring List prior to running. It is the owner's responsibility to have a dog measured prior to running. Failure to do so will result in the cancellation of any qualifying score or award.

#### **Change of Entry**

As described in Chapter 1, Section 21 of the AKC Regulations for Agility Trials, a dog entered in a Novice A class, for which it is not eligible, may be moved to Novice B. In addition, if after closing AKC notification is received in writing that a dog is not eligible for a class as entered, the dog may be moved to the correct class. The request for a change of entry MUST be made at least 30 minutes prior to the start of the agility trial. If at an agility trial a VMO or Field Representative measures a dog into a height other than as entered, the entry may be changed from Regular to Preferred or vice versa as long as the dog has not run any classes that day. If the dog has already run, the change may be made for the next trial day(s). When requesting such a change of entry, an exhibitor must provide the Trial Secretary with the AKC Agility Measurement Form.

#### **Ineligibility to Compete**

Blind dogs, bitches in season, aggressive dogs, or dogs suffering from any deformity, injury or illness which may affect the dog's physical or mental performance are <u>not</u> eligible to compete. These agility trials are open to dogs 15 months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration or Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP).

#### **Move-up Request**

As per AKC regulations, a dog may move-up to the next level of competition as a result of earning an agility title after the closing date of these trials. A day-to-day move-up request, allowed for only dogs entered in these back-to-back agility trials, MUST be delivered in writing to the Trial Secretary no later than 15 minutes after the last run in the first trial. A move-up request MUST be made in writing by postal mail or by email, providing the dog's name, owner's name, original class entered as well as new class requested, and accepted by the Trial Secretary, no later than 6:00 pm CT on Monday, May 1, 2024; NO telephone or verbal requests will be accepted.

#### Refund of Entry Fees

Entry withdrawals after the closing date due to a change of judge will receive a full refund. Entry fees (less \$10.00 per class/per event) will be refunded to agility entrants for bitches in season after the closing date with a written veterinarian certification. A written refund request must be provided to the Trial Secretary at least 30 minutes prior to the start of agility judging.

## AGILITY HIGH IN TRIAL AWARD FOR NORWEGIAN ELKHOUNDS ONLY!

**Guidelines and Rules** 

All Norwegian Elkhounds competing in the Standard agility classes, including all jump heights, shall be eligible for the NEAA Agility High in Trial Award. The award shall be based on the qualifying course run results from only the Standard agility classes.

A dog must have a Standard class qualifying score to be eligible for the NEAA Agility High in Trial Award.

#### Order of consideration for NEAA Agility High in Trial Award:

- 1. Dog/handler team(s) with a double qualify\* (2Q's)
- 2. Dog/handler team(s) with a Standard qualifying score of 100
- 3. Dog/handler team(s) with a Standard qualifying score of less than 100

\*Qualifying score at the same trial in both the Standard class and the Jumpers with Weaves class (double Q)

At the end of the agility trial, first to be considered for NEAA Agility High in Trial shall be a dog/handler team(s) with a double qualify. A dog with a Double Q shall be weighted more than a dog with a single Standard qualifying score. If none, a dog/handler team(s) with a perfect Standard qualifying score of 100 shall be considered next. If none, a dog/handler team(s) with a Standard qualifying score of less than 100 shall be considered. Qualifying scores for AKC Standard and Jumpers with Weaves agility classes: Novice A&B, Open, and Excellent – 100 to 85 minimum; Masters – 100 minimum.

Within each Standard agility class, bonus points shall be awarded based on the level of difficulty. In all team situations, the resulting highest score wins NEAA Agility High In Trial.

A scoring record for the NEAA Agility High In Trial Award shall be kept at the trial indicating the armband number of each competing dog, the dog's call name, Standard class level, Standard course time in seconds (SCT), actual Standard course running time in seconds (rounded down) for each competing dog, qualifying score in a Standard class, notation if a double Q was earned by a competing dog, and the final calculated score for NEAA Agility High In Trial. For example, if the SCT is 65 seconds and a dog runs the Standard course in 60.3 seconds, the difference would round down to 5 seconds.

One High In Trial winner is chosen per difficulty level; there is no separate High In Trial for the Novice A and Novice B sections. The High in Trial is determined by adding the team's faults across the elements. If there is a tie based on faults, then the team's times across the elements will be summed and the faster-finishing team will win. The High in Trial award is not recorded by the AKC. Teams winning High In Trial will be awarded a special Rosette.

# STAGING AREA, HANDLER'S BRIEFING, AND WARM-UP INFORMATION

**Staging Area** will be out of view of search area(s). Staging area will include warm-up and waiting area, as well as posting of running order.

The **Handler's Briefing** will take place in view of the search area prior to the start of each class, after the hide(s) have been set and after the Demo Dog has run. In the Handler's Briefing the judge will explain if there's an offleash option, number of hides, maximum height of hides and maximum time for the search. NO DOGS are to be present during the Handler's Briefing.

**Warm-up area:** the club shall designate a warm-up area. One labelled container per target odor being used in the trial on that day will be placed in the warm-up area. This will allow handler-dog teams to prepare themselves for the search prior to their run. Each team should limit their warm-up to two minutes or less so that others may be able to use the warm-up area.

# "WORK" ADDITIONAL SITE INFORMATION

**Trial Site.** It is not appropriate to scout the trial location prior to the trial date. Many search locations are real-life environments, and such visits may risk the host losing the opportunity to use the location in the future.

**Possession of Odors and Training**. Chapter 5. Section 35 of the Scent Work Regulations state "No person other than those engaged in the administration of a trial shall be in possession of any target odor when on the trial grounds. There shall be no training on the grounds of the AKC Scent Work trial, other than the designated warm-up area".

**Spectator Area.** Spectators are encouraged as allowed with the Covid protocol in effect at the time of the trial and by space limitations. Any person not handling a dog in the current class, or any person who has already completed their run in the class may choose to watch the search from the spectator area. Handlers may not watch other exhibitors from their class prior to their run except in the case of Handler Discrimination classes. No one outside the search area may assist the handler or disclose the location of the hide.


# Class Eligibility.

- Novice A Classes are open to dogs who have not completed any title for that particular element, who have not completed a comparable title with another organization, and whose handlers are neither Scent Work judges, nor have ever worked as professional detection dog handlers.
- Novice B Classes are open to all dogs.

Dogs that have previously earned the same or higher level AKC Scent Work titles may enter lower-level classes. Dogs are able to enter up to two (2) difficulty levels in each element, in each trial. If a dog is entered in more than two difficulty levels for a single element in a single trial, the score for the lowest level entered will be disallowed, regardless of whether the dog ran or qualified in all levels. Dogs may only enter classes for which they are eligible, according to the above guidelines. Dogs may only enter a class once in each event. A class is defined as a particular difficulty level within a particular element. For example, a dog may run in both Novice and Advanced Interior in the same trial but may not run in Novice Interior twice in the same trial.


# **DIRECTIONS TO PURINA FARMS**

# **RV PARKING AT PURINA**

There is nothing better than staying on site at Purina Farms in the RV Parking. Purina Farms has full service amenities Service Center that is open 24/7. Inside the Service Center you'll find dog-bathing tubs and showering facilities. Outside, there are two separate fenced-in, well-lit yards for exercising dogs.



All RV spaces have full hookups with 50 amp power, water and sewer hookup. The nightly charge is \$50/night (Row A), \$45/night (Row B) and \$40/night (Rows C & D). NOTE: Row A sites are limited and are pre-assigned to the Show Chairs and Show Secretary. Full payment by credit card must be received before the space can be confirmed and finalized. There is no guarantee of site assignment. Prepare to have extra sewer hose as your hookups might be on the opposite side than your tank.

The first night of your overnight camping reservations for the Norwegian Elkhound Association of America Nationals must start no earlier than May 4, 2024 and must end by 10a.m. on May 12, 2024. Our RV Engagement Specialist will respond back to your reservation request within 5- 7 business days to let you know whether your reservation is confirmed. Full payment must be received before the space can be finalized.

Purina Farms offers 2 different RV lots on property. The Full Service Purina Event Center RV lot offers 30 and 50 amp electric, water and sewer. The Electric Only Main Show Field RV lot offers 30 and 50 amp electric.

The nightly charge is \$50/night (Row A), \$45/night (Row B) and \$40/night (Rows C & D) in the Full Service Purina Event Center Lot\* and \$25 in the Electric Only Main Show Field RV Lot. Full payment by credit card must be received before the space can be confirmed and finalized. There is no guarantee of site assignment.

Any RVs bigger than 50' must reserve a spot in the full-service Purina Event Center lot. Max size of RV on property is 55'. Tow vehicles are not factored into the length of the spaces as they must be unhooked.

# INCLEMENT WEATHER

In the event a severe weather or tornado warning is issued for the immediate area, Site Security will notify the Purina Farms management team. The team will notify guests of an impending weather event via the property-wide public address system and via the storm siren and announcements. Guests will be asked to seek cover in designated areas marked as severe weather shelter areas inside the Purina Farms facilities (those in the outdoor event areas should seek cover in one of the indoor facilities on the property). Areas at the Purina Event Center include the Gateway Hall, restrooms, South stairwell and the Great Hall if necessary. Areas at the Visitor Center include the bathrooms and indoor theater. After the weather event ends, Purina Farms management teams will announce all clear.

- If weather is extreme after-hours, then security will unlock the Purina Event Center to allow overnight guests to come into the building with dogs at any time. The service center is also open 24/7 for campers to seek shelter.
- Should the weather look threatening, Purina Farms Security will go around the RV lot to notify overnight guests to seek shelter. Security will also visit the outdoor event areas around the property to let guests know there is threat.

# **Property Access and Building Hours**

- o The front Purina Farms entrance/exit gate is manned daily by a security guard from 6a.m. 6p.m. to allow access to the property. Gates may be closed outside of these hours, but access to and from the property is still possible by pushing a call button at the gate or calling security at 636-221-1428 or 314-982-2217. The exit gate automatically opens to allow guests to leave.
- Regular Purina Event Center building hours are 6a.m. 6p.m. unless otherwise posted.

### Clean-up

- Guests are responsible for cleaning up after their dogs. This includes properly disposing of waste and using designated relief areas and the public x-pen area on the East side of the Gateway Hall for all elimination needs.
- Designated stations throughout the facility should be used appropriately (i.e. watering station should not be used for waste or other materials and bathing tubs should not be used for cleaning crates.)

# Grooming

- 20 amps of electric service available per assigned space inside the facility.
- All grooming in The Great Hall must be on 4mil plastic that covers the floor.
- Rubber caps for the tables are available if tables appear they will damage the flooring.

### Food and Beverage

- Need to be purchased through the on-site food service and catering company.
- No outside food or beverage, or outside food service/catering company, is allowed on the Purina Farms property (unless organization receives written permission from Purina Farms management).
- Any violation will be reported to the AKC or the appropriate sanctioning entity of the event.

# Dogs

- No dogs are allowed, except for service dogs: in the Checkerboard Café, on the second floor of the Purina Event Center (unless given prior permission) and in any restroom or human bathing area.
- All dogs are required to be on-leash at Purina Farms at all times (except when crated or as required to be judged.)
- o No swimming (dogs and people) allowed in any ponds on the property.
- o No dogs should be left unattended in the off-leash exercise areas or the public outdoor x-pens around the

### Parking

- No parking in the following areas: Fire lanes, inside either Hall (No vehicles are allowed to drive inside either hall) or on the sidewalks leading into either Hall except where loading and unloading is designated. In addition, no driving is allowed on sidewalks.
- Driving or parking on any grass at Purina Farms is prohibited.
- All guests must abide by the 15-minute unloading/loading parking time limit designated around the Purina Event Center.

### Supplies

 Duct tape may not be used in the building. Only painter's tape and gaffer's tape can be used on the floor and walls of the facility.

### General

- No helium balloons in either hall. Balloons can be used in the Founder's Room (with approval from Purina Farms management). No glitter, confetti or candles allowed.
- Public intoxication is prohibited at Purina Farms.
- o No exercise pens allowed around the front and back of the Purina Event Center or the grassy area adjacent to the East side of the Gateway Hall. Overall, exercise pens around the perimeter of the entire building are strongly discouraged. Any exercise pens on designated grassy areas should not have a flooring/covering to prevent damage to the grass.
- Shavings may not be used on any grass around Purina Farms.
- Children must be supervised and accompanied by an adult at all times when on the grounds (including the Purina Farms Visitor Center and especially on the balcony at the Purina Event Center).
- Guests accept personal liability with respect to any claim made in respect to any damage or injury caused by their dogs or dogs in their possession.
- Smoking, including the use of electronic cigarettes, is prohibited in buildings.
- Weapons of any kind, illegal drugs and fireworks are not permitted on the premises.

Special Notes: Purina Farms staff reserves the right to refuse entry to any party/person or animal and retains the right to remove any person or persons and/or any animal from the premises (with no refund if applicable) in order to ensure the safety and enjoyment of any and all guests, including dogs and cats. Purina Farms is not responsible for the actions of any guest to the property, including animals.
