DOGS ELIGIBLE TO ENTER

The trial is open to all dogs SIX (6) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP), an AKC Canine Partners listing number or approved Foundation Stock Service (FSS) breeds are eligible to participate. Dogs with a Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number must be spayed or neutered in order to compete. Wherever the word "dog" is used in these regulations it includes both sexes.

Condition of the dog. Dogs with physical challenges (including amputees) are eligible to participate provided that, in the opinion of the judge, the dog displays no sign of physical discomfort and can safely complete the search. Deaf and blind dogs are allowed to enter. Dogs that are both deaf and blind are able to participate so long as the handler is in control of the dog at all times, the dog can complete the requirements of the class, and the dog does not appear to be under undue stress in the opinion of the judge. Females in season may not participate; aggressive dogs, or dogs suffering from an injury, or illness which may affect the dog's physical or mental performance may not participate. No dog shall compete if it is sutured, bandaged, or has any visible wounds.

"Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations." Additionally, clubs should include any specific local or state health requirements; for example, proof of rabies vaccination.

WORKERS

No entry shall be made and no entry shall be accepted which specifies any conditions as to its acceptance. You will be notified if you are in the trial only after the show closes.

Illegible entries (including early entries) will not be processed and will be destroyed. Returned checks do not constitute a valid entry and the Trial Secretary will add a \$50.00 fee for each returned check. Subsequent returned checks from the same exhibitors may result in further entries being accepted on a cash-only basis.

HANDLER BRIEFING, WARM UP AREA

The Handler's Briefing will take place in view of the search area prior to the start of each class, after the hide(s) have been set and after the Demo Dog has run. In the Handler's Briefing the judge will explain if there is an off-leash option, number of hides, maximum height of hides and maximum time for the search. NO DOGS are to be present during the Handler's Briefing.

A warm-up area will be available. One labeled container per target odor being used in the trial on that day will be placed in the warm-up area. This will allow handler-dog teams to prepare themselves for the search prior to their run. Exhibitors should limit their warm-up to (2) two minutes or less. The warm-up area is to be used exclusively for warming up the handler dog team prior their run. The warm-up area is not for training or relieving of the dog.

SEARCH AREA AND RING CONDITION

Search areas may be of any shape, and of the size specified in the Regulations for each class.

Search Area Conditions. Searches may be held indoors on concrete, matted, carpeted or tiled surfaces and outdoors on grass, gravel, sand, concrete, or asphalt surfaces.

Search Area Sizes will be as stated in the AKC Regulations.

ADDITIONAL INFORMATION

Trial Site. It is not appropriate to scout the trial location prior to the trial date. Many search locations are real-life environments and such visits may risk the host losing the opportunity to use the location in the future.

***Please note that this trial will take place at 2 different locations with an approximate 10 minute drive between sites. All levels of exterior will run at Notebook Learning Center, along with excellent and master interior and some of the HD and detective trials. All levels of container and buried will run at the American Legion Post #157, along with novice and advanced interior and some of the HD and detective trials. Further information regarding exact locations will be emailed to exhibitors in the final confirmation letter.

Restroom access at Notebook Learning Center will be unavailable at certain times while interior classes are running. Restrooms will be available at all times at the American Legion Post.

Possession of Odors and Training. Chapter 5. Section 35 of the Scent Work Regulations state "No person other than those engaged in the administration of a trial shall be in possession of any target odor when on the trial grounds. There shall be no training on the grounds of the AKC Scent Work trial, other than the designated warm-up area".

Spectator Area. Spectators will be allowed. Spectators must check in with the check in table.

Crating. Plan to crate in your vehicles. Make sure you plan accordingly to make sure the dogs are comfortable. **THERE WILL BE NO INDOOR CRATING AT THIS TRIAL**.

Exhibitors are responsible for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Event Committee deems the exhibitor to be in violation of this requirement. Cleaning supplies and disposal sites will be available at various locations.

Food. There will NOT be any vendors on site.

RINGSIDE. Judges are not required to wait for dogs. The Owner of each dog is solely responsible for having it ready at the search area when it is to be judged. The Club has no responsibility to provide service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required.

NO same day move ups will be available. If your team obtains a title on March 8th and you are looking to move to a different level for March 9th that will be accepted.

SAFETY BEHAVIOR AND LIABILITY

The safety of the dog is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all searches safely. It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor, dogs and/or children that create an unnecessary disturbance or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the trial committee and chairperson, be asked to leave the show site. In such case, no refund of any fees paid will be made. The American Pomeranian Club and its agents, employees, etc. or trial site owners, will assume no responsibilities for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dogs or property and further assumes no responsibility for injury to children. The Club reserves the right to decline entries for cause and may remove any dog on account of aggression. No one shall have any recourse or claim against the Club or any official thereof.

Collars, Leashes and Harnesses. During searches, dogs must wear a properly fitted collar or harness approved by the judge. A wearable camera such as a Go Pro may be mounted to the dog's harness, if desired. Leashes may be of any length and/or retractable. The leash should be made of plain, pliable material.

All dogs must be on leash at all times. Dogs must enter and exit the search area with the leash attached to the collar or harness, including when waiting in the search area before and after the search. An off- leash option may be offered at the discretion of the judge, only if the area is completely enclosed. Handlers always have the option to run detective class off leash, regardless of whether the area is completely enclosed.

REFUNDS

No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee. No entry fee will be refunded in the event a dog is absent, disqualified, excused, or barred from competition by the action of the Trial Committee. Dogs pulled after closing because of injury or other medical condition will be given a refund minus the AKC fees of \$3.50/run with a veterinarian note. Note must be given to the trial secretary no later than one half hour prior to the start of the first class of the day of the trial.

Bitches in season will be refunded the full entry fee minus \$5.00 processing fee. Notification in writing from veterinarian must be given to the trial secretary no later than one half hour prior to the start of the first class of the day of the trial.

Placement Double flat ribbon will be awarded in each class for first though fourth place **A dark green** flat ribbon will be awarded for each qualifying score

New Title Element double flat ribbon will be awarded to all dog and handler teams finishing an element title

New Title Level or Elite Rosette will be awarded to all dog and handler teams finishing an overall title **Detective Rosette** will be awarded to all dog handler teams finishing a detective title

High In Trial Novice rosette will be awarded to the team with the fewest faults/fastest time who qualifies in each of the Novice classes: Container, Buried, Exterior, and Interior.

High In Trial Advanced rosette will be awarded to the team with the fewest faults/fastest time who qualifies in each of the Advanced classes: Container, Buried, Exterior, and Interior.

High In Trial Excellent rosette will be awarded to the team with the fewest faults/fastest time who qualifies in each of the Excellent classes: Container, Buried, Interior and Exterior.

High In Trial Master rosette will be awarded to the team with the fewest faults/fastest time who qualifies in each of the Master classes: Container, Buried, Interior and Exterior.

High Combined Division rosette will be awarded at each level: Container, Buried, Exterior, Interior and Handler Discrimination

Pomeranians must be entered in each of the 4 elements (interior, exterior, buried and container) to receive the award. Tie breakers will be determined by the fastest qualifying time in the interior element. If neither dog qualified in the interior element, award will be presented to the Pomeranian with the fastest combined tallied times from all elements in which they received a qualifying score within the novice level.

High In Trial Advanced will be awarded for each trial on Saturday and Sunday. High in Trial Pomeranian advanced awards will be scored by the most amount of qualifying scores in the advanced level. Pomeranians must be entered in each of the 4 elements (interior, exterior, buried and container) to receive the award. Tie breakers will be determined by the fastest qualifying time in the interior element. If neither dog qualified in the interior element, award will be presented to the Pomeranian with the fastest combined tallied times from all elements in which they received a qualifying score within the advanced level.

High In Trial Excellent will be awarded for each trial on Saturday and Sunday. High in Trial Pomeranian excellent awards will be scored by the most amount of qualifying scores in the excellent level. Pomeranians must be entered in each of the 4 elements (interior, exterior, buried and container) to receive the award. Tie breakers will be determined by the fastest qualifying time in the interior element. If neither dog qualified in the interior element, award will be presented to the Pomeranian with the fastest combined tallied times from all elements in which they received a qualifying score within the excellent level.

High In Trial Master will be awarded for each trial on Saturday and Sunday. High in Trial Pomeranian master awards will be scored by the most amount of qualifying scores in the master level. Pomeranians must be entered in each of the 4 elements (interior, exterior, buried and container) to receive the award. Tie breakers will be determined by the fastest qualifying time in the interior element. If neither dog qualified in the interior element, award will be presented to the Pomeranian with the fastest combined tallied times from all elements in which they received a qualifying score within the master level.

High Scoring Detective will be awarded to the Pomeranian receiving the most cumulative qualifying scores over the 6 trials Friday, Saturday and Sunday. Tie breaker will be determined by fastest qualifying time within the novice level.

High Scoring HD will be awarded to the Pomeranian receiving the most cumulative qualifying scores over the 4 trials in the Handler Discrimination division. Tie breaker will be determined by the fastest qualifying time.
