



• Generations Class (National <u>only</u>): For three dogs, regardless of sex, of three consecutive generations (grandparent, parent, offspring). <u>Entry is made for each dog (three separate entry forms)</u> and all entries submitted together. Class is judged on the merits of all three generations entered.

**Best Bred by Exhibitor entered in National Specialty:** Following the award of Best of Breed the winners of the Bred by Exhibitor Puppy and Adult Classes in each sex, will return to the ring. The judge will then select the Best Bred by Exhibitor entered in the specialty. The winner will receive a certificate for "One free Litter Registration offered by AKC"

JUNIOR SHOWMANSHIP

**Novice Class:** This shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show and who at the time entries close have not won three (3) first place awards, with competition present, in a Novice Class. A first place in Novice without competition leading to a Best Junior award with competition would count as one win towards moving to Open at a licensed or member show. Junior Handlers who win a third Novice Class with competition, if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open, after the closing of entries for a show are required to transfer their entry from the Novice Class to the Open Class by notifying the Superintendent or Show Secretary prior to the judging of the class at the show.

**Open Class:** This class shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show, and who have won three first place awards in a Novice Class or if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open in a licensed or member show.

**Master Class:** This class will be for boys and girls who are at least 9 years old and under 18 years on the day of the show, and who have won the 10 Best Junior wins with competition. The calendar for this class will be consistent with the eligibility dates for the AKC National Championship. All Juniors meeting the criteria for this class are required to enter the Master Class and must change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to complete for the following year.



Dominique Mercurio was a strong advocate for performance

events at our National Specialty, whether it was personally participating with her own dogs, generously working events, or advocating for new opportunities like barn hunt and herding. She also loved her time in the breed ring and if she couldn't be out there on the other end of the lead, she made sure somebody else could show her dogs.

Through the gracious memorial donations made to the club on her behalf, NEAA has created the NEAA National Specialty Versatile Elkhound Award in memory of Dominique to honor her versatility legacy. This award will be presented to the dog, or dogs entered in the most events at the National. There is no need for a qualifying score or a placement, Dominique was about just trying and getting to work with your dog as a team, no matter the outcome.

Here's how it works.

The conformation entry will count as one (but only one) and all classes qualify for that count, including classes such as

Generations, Brace, Sweeps etc.

Each separate Performance event entry counts as one. Example: an entry in agility and rally would count as 2 but an entry in 2 agility classes will only count as 1.

So, the maximum score any team can receive is 5 (any conformation entry + agility + obedience + rally + scent work = 5).

If there are multiple teams with the same top score, all those teams will receive the award.

We will present this award to the winner(s) at the awards banquet, so please plan on attending.

#### Class Changes Effective January 1, 2020

### Entering a Mixture of Regular and Preferred Classes Within the Same Trial Weekend – Multiple Jump Heights Within the Same Trial Day

**Effective January 1, 2020**, exhibitors may enter a mixture of both Regular and Preferred classes on the same trial day and/or during a trial weekend. **Any mixture of Regular and Preferred classes is allowed.** Please note that if a dog qualifies in Regular Master Standard and Preferred Master JWW (or vice versa) on the same trial day, **then NO Double Q shall be earned toward either the MACH or PACH title**. The Double Q still requires that Standard Agility and Jumpers with Weaves be either both Regular OR both Preferred on the same trial day.

Additionally, within the same Regular or Preferred classes, a dog may now be entered in multiple jump heights within the same trial day. For example, the same dog may now be entered in 20-inch Master STD/JWW while also entered in 24C-inch Premier STD/JWW on the same trial day.

<u>A separate entry form must be submitted</u> when the same dog is being entered in a mixture of Regular and Preferred and/ or different jump heights within the same trial weekend thereby clearly indicating which class(es) and/or jump heights belong together for each trial day of the weekend.

By entering these trials, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their Norwegian Elkhounds are familiar with and able to perform all obstacles safely. Except for dogs needing measurement, dogs are not required to be at the trial until their scheduled time of judging. The owner/handler of each dog is solely responsible for having it ready at ringside when the class is to be judged.

#### **Entering For Exhibition Only (FEO)**

#### Entering For Exhibition Only (FEO)

- For Exhibition Only may be offered at the option of the host club. FEO will allow exhibitors to work with their dogs in a trial environment.
- \* FEO runs are treated as trial entries. The exhibitor must enter the class (es) prior to the closing date, pay class entry fees and the Trial Secretary must record the entry in the Trial Catalog as part of the results for that class. FEO does not need to be noted on the entry form; the handler will declare the day of the show.
- \* Changes are not allowed.
- \* Dogs may be entered at any level (Novice, Open Excellent or Masters) in FAST, JWW, Standard or Premier classes. If entered in an ineligible jump height, the team is committed to FEO for that run and must declare FEO on the start line. Day of show jump height changes are not allowed.
- \* Dogs may be entered in any level of FAST (Novice, Open, Excellent, Master). If the dog is not eligible for the level entered, the team is committed to FEO for that run and must declare FEO on the start line. Day of show level changes are not allowed.
- \* The exhibitor must declare FEO in the ring prior to leading out to the scribe and the judge.
- \* Course time for FEO in Time 2 Beat, JWW, Standard, Premier and ISC will be 45 seconds. FAST courses times for each class/ height are as noted in the Regulations.
- \* Effective July 1, 2024, the fault call scored for an FEO run shall be changed from Excused ("E") to Absent ("ABS"). Scribes should continue to write "FEO" on the scribe sheet; however, the Score Table shall now enter that run as an Absent run. In doing so, the Defeated Dogs report used by Breed Specialty clubs will no longer have FEO runs in their Number of Dogs Entered calculations nor will FEO runs affect calculations where Number of Dogs Competing are involved, such as calculating Premier Top 25% counts. This change is for all classes: Standard, Jumpers With Weaves, FAST, Time-2-Beat, Premier Standard, Premier Jumpers, ISC Agility, ISC Jumping, ACT and ACTJ.

#### Fix and Go On (FNG)

• Fix and Go On is not pre-entered; rather, it occurs during the course of the run.

• FNG allows exhibitors to immediately reattempt an obstacle at any time while on course when the dog's performance of an obstacle is not to their expectation. This allows the dog to successfully complete the obstacle then finish the course or leave the ring on a positive note. Using FNG will result in a non-qualifying score.

#### Acceptance of Entries

First received (entries accepted in order of receipt); 300 run limit for this trial. Agility classes will run indoors on artificial turf; electronic timing and rubberized contacts will be used. Agility entries **OPEN** at 8:00 am CT, Tuesday, April 1, 2025 for Norwegian Elkhounds and April 14th for all other breeds. Agility entries **CLOSE** at 6:00 pm CT, Wednesday, May 21, 2025, at the Trial Secretary's office.

#### Jump Height Card

Owners are responsible for entering their dog in the proper jump height class. All dogs participating in these trials must have an AKC Jump Height Card or check the box on the entry form to place your dog on the Measuring List prior to running. It is the owner's responsibility to have a dog measured prior to running. Failure to do so will result in the cancellation of <u>any</u> qualifying score or a<u>ward</u>.

#### Change of Entry

As described in Chapter 1, Section 21 of the *AKC Regulations for Agility Trials*, a dog entered in a Novice A class, for which it is not eligible, may be moved to Novice B. In addition, if after closing AKC notification is received in writing that a dog is not eligible for a class as entered, the dog may be moved to the correct class. The request for a change of entry MUST be made at least <u>30</u> minutes prior to the start of the agility trial. If at an agility trial a VMO or Field Representative measures a dog into a height other than as entered, the entry may be changed from Regular to Preferred or vice versa as long as the dog has not run any classes that day. If the dog has already run, the change may be made for the next trial day(s). When requesting such a change of entry, an exhibitor must provide the Trial Secretary with the AKC Agility Measurement Form.

#### **Ineligibility to Compete**


Blind dogs, bitches in season, aggressive dogs, or dogs suffering from any deformity, injury or illness which may affect the dog's physical or mental performance are <u>not</u> eligible to compete. These agility trials are open to dogs 15 months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration or Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ ILP).

#### Move-up Request

As per AKC regulations, a dog may move-up to the next level of competition as a result of earning an agility title after the closing date of these trials. A day-to-day move-up request, allowed for only dogs entered in these back-to-back agility trials, MUST be delivered in writing to the Trial Secretary no later than <u>15</u> minutes after the last run in the first trial. A move-up request MUST be made in writing by postal mail or by email, providing the dog's name, owner's name, original class entered as well as new class requested, and accepted by the Trial Secretary, <u>no later than 6:00 pm CT on Monday, June 2</u>, <u>2025</u>; <u>NO telephone or verbal requests will be accepted</u>.

#### **Refund of Entry Fees**

Entry withdrawals after the closing date due to a change of judge will receive a full refund. Entry fees (less \$10.00 per class/per event) will be refunded to agility entrants for bitches in season after the closing date with a written veterinarian certification. A written refund request must be provided to the Trial Secretary at least <u>30</u> minutes prior to the start of agility judging.



# AGILITY HIGH IN TRIAL AWARD FOR NORWEGIAN ELKHOUNDS ONLY!

All Norwegian Elkhounds competing in the Standard agility classes, including all jump heights, shall be eligible for the NEAA Agility High in Trial Award. The award shall be based on the qualifying course run results from only the Standard agility classes.

A dog must have a Standard class qualifying score to be eligible for the NEAA Agility High in Trial Award.

# Order of consideration for NEAA Agility High in Trial Award:

- 1. Dog/handler team(s) with a double qualify\* (2Q's)
- 2. Dog/handler team(s) with a Standard qualifying score of 100
- 3. Dog/handler team(s) with a Standard qualifying score of less than 100

\*Qualifying score at the same trial in both the Standard class and the Jumpers with Weaves class (double Q)

At the end of the agility trial, first to be considered for NEAA Agility High in Trial shall be a dog/handler team(s) with a double qualify. A dog with a Double Q shall be weighted more than a dog with a single Standard qualifying score. If none, a dog/handler team(s) with a perfect Standard qualifying score of 100 shall be considered next. If none, a dog/handler team(s) with a Standard qualifying score of less than 100 shall be considered. Qualifying scores for AKC Standard and Jumpers with Weaves agility classes: Novice A&B, Open, and Excellent – 100 to 85 minimum; Masters – 100 minimum.

Within each Standard agility class, bonus points shall be awarded based on the level of difficulty. In all team situations, the resulting highest *score wins NEAA Agility High In Trial.*


A scoring record for the NEAA Agility High In Trial Award shall be kept at the trial indicating the armband number of each competing dog, the dog's call name, Standard class level, Standard course time in seconds (SCT), actual Standard course running time in seconds (rounded down) for each competing dog, qualifying score in a Standard class, notation if a double Q was earned by a competing dog, and the final calculated score for NEAA Agility High In Trial. For example, if the SCT is 65 seconds and a dog runs the Standard course in 60.3 seconds, the difference would round down to 5 seconds.



Dogs entered in the Preferred classes must compete at the required jump height and may not compete in a jump height division higher or lower than their proper height division.



# DOGS ELIGIBLE TO ENTER

This trial is open to all AKC Registered Norwegian Elkhounds SIX (6) months of age or older that are registered with the American Kennel Club or have Purebred Alternative Listing as Norwegian elkhound.

**Condition of the Dog.** Dogs with physical challenges (including amputees) are eligible to participate provided that, in the opinion of the judge, they display no signs of physical discomfort and can safely complete the search. Dogs with bandages, sutures, or visible wounds are not eligible. Deaf dogs and blind dogs are allowed to enter. Dogs that are both deaf and blind are able to participate so long as the handler is in control of the dog at all times, the dog can complete the requirements of the class, and the dog does not appear to be under undue stress in the opinion of the judge.

# ENTRY FEES

\*An entry is defined as a single run by a single dog in a single class. Entry fees include a \$3.50 per run AKC recording fee.

# WAIT LIST/MOVE UP INFORMATION

If the trial fills by/before closing date, NEAA is offering a wait list of 10 entries to fill openings created by withdrawn entries after the trial's closing date/time. Entries must be received by the trial's closing date and time. If an entry is pulled after closing, the opening will be offered to the first exhibitor in wait-list order. If they turn down the opening, they can choose to be placed last on the wait list or ask for a refund.

On the day of the trial, the club will assign entries for absent individuals to those on the wait list who are present at the trial site. If multiple wait listed individuals are present at the event site, the runs will be assigned in wait-list order.

# A full refund is to be reimbursed to any entrant whose entry is replaced by a wait-listed entry.

Move up deadline is June 2, 2025, or 30 minutes before the trial starts. Move-ups, for trial 2, will be accepted until 30 minutes before Trial 2 begins.

# **SCENT WORK HIGH IN TRIAL**

Only teams who participate in the same difficulty level in all elements offered (Container, Interior, Exterior, Buried, and qualify in each are eligible to win **High in Trial**. One High In Trial winner is chosen per difficulty level; there is no separate High In Trial for the Novice A and Novice B sections. The High in Trial is determined by adding the team's faults across the elements. If there is a tie based on faults, then the team's times across the elements will be summed and the faster-finishing team will win. The High in Trial award is not recorded by the AKC. Teams winning High In Trial will be awarded a special Rosette.

# STAGING AREA, HANDLER'S BRIEFING, AND WARM-UP INFORMATION

**Staging Area** will be out of view of search area(s). Staging area will include warm-up and waiting area, as well as posting of running order.

The **Handler's Briefing** will take place in view of the search area prior to the start of each class, after the hide(s) have been set and after the Demo Dog has run. In the Handler's Briefing the judge will explain if there's an off-leash option, number of hides, maximum height of hides and maximum time for the search. NO DOGS are to be present during the Handler's Briefing.

**Warm-up area:** the club shall designate a warm-up area. One labelled container per target odor being used in the trial on that day will be placed in the warm-up area. This will allow handler-dog teams to prepare themselves for the search prior to their run. Each team should limit their warm-up to two minutes or less so that others may be able to use the warm-up area.

# SEARCH AREA AND RING CONDITIONS

**Search Area Conditions**. Searches may be indoors, on matted, carpeted, or tiled surfaces, or outdoors on grass, gravel, earth, concrete, or asphalt surfaces.

# **"WORK" ADDITIONAL SITE INFORMATION**

**Trial Site.** It is not appropriate to scout the trial location prior to the trial date. Many search locations are real-life environments, and such visits may risk the host losing the opportunity to use the location in the future.

**Possession of Odors and Training**. Chapter 5. Section 35 of the Scent Work Regulations state "No person other than those engaged in the administration of a trial shall be in possession of any target odor when on the trial grounds. There shall be no training on the grounds of the AKC Scent Work trial, other than the designated warm-up area".

**Spectator Area.** Spectators are encouraged as allowed with the Covid protocol in effect at the time of the trial and by space limitations. Any person not handling a dog in the current class, or any person who has already completed their run in the class may choose to watch the search from the spectator area. Handlers may not watch other exhibitors from their class prior to their run except in the case of Handler Discrimination classes. No one outside the search area may assist the handler or disclose the location of the hide.

**Crating information will be sent out in the welcome letter.** Please refer to the premium list for the NEAA Specialty at www.NEAA.net for more information. The **NEAA** and **Purina Farms** will not be responsible for any lost or damaged items left at the show site.

**Exhibitors are responsible** for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Event Committee deems the exhibitor to be in violation of this requirement. Cleaning supplies and disposal sites will be available at various locations around the show grounds.

# NOTICE TO SCENT WORK EXHIBITORS

# SAFETY, BEHAVIOR and LIABILITY

The safety of the dog is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all searches safely. It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create an unnecessary disturbance or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the trial committee, be asked to leave the show site. In such case, no refund of any fees paid will be made. The NEAA and its agents, employees, etc., will assume no responsibilities for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dogs or property and further assumes no responsibility for injury to children. The NE-AA reserves the right to decline entries for cause and may remove any dog on account of aggression. No one shall have any recourse or claim against the NEAA or any official thereof.

**Collars, Leashes and Harnesses.** During searches, dogs must wear a properly fitted collar or harness approved by the judge. A wearable camera such as a Go Pro may be mounted to the dog's harness, if desired. Leashes may be of any length and/or retractable. The leash should be made of plain, pliable material.

**All dogs must be on leash** at all times, and retractable leashes may not be used when on trial grounds (except during judged searches). Dogs must enter and exit the search area with the leash attached to the collar or harness, including when waiting in the search area before and after the search. An off-leash option may be offered at the discretion of the judge, only if the area is completely enclosed.

#### REFUNDS

**No entry fee** will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee. No entry fee will be refunded in the event a dog is absent, disqualified, excused, or barred from competition by the action of the Trial Committee. Dogs pulled after closing because of injury or other medical condition are not eligible for a refund.

**Bitches in season** will be refunded the full entry fee minus a \$2.50 handling fee. Notification in writing must be given to the trial secretary no later than one half hour prior to the start of the first class of the day of the trial.

# RINGSIDE

**Judges are not required** to wait for dogs. The Owner of each dog is solely responsible for having it ready at the search area when it is to be judged. The Club has no responsibility to provide service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required.

**EXHIBITOR CHECK-IN**: At check-in you will receive your armband number. Once the time and location for check-in is determined all exhibitors will be notified by email.

#### Exhibitors MUST check-in the day they are entered.

#### This club does not agree to arbitrate claims as set forth on the Official AKC entry form for this event.

# Class Eligibility.

• Novice A Classes are open to dogs who have not completed any title for that particular element, who have not completed a comparable title with another organization, and whose handlers are neither Scent Work judges, nor have ever worked as professional detection dog handlers.

• Novice B Classes are open to all dogs.

Dogs that have previously earned the same or higher level AKC Scent Work titles may enter lower-level classes. Dogs are able to enter up to two (2) difficulty levels in each element, in each trial. If a dog is entered in more than two difficulty levels for a single element in a single trial, the score for the lowest level entered will be disallowed, regardless of whether the dog ran or qualified in all levels. Dogs may only enter classes for which they are eligible, according to the above guidelines. Dogs may only enter a class once in each event. A class is defined as a particular difficulty level within a particular element. For example, a dog may run in both Novice and Advanced Interior in the same trial but may not run in Novice Interior twice in the same trial.

# **OVERNIGHT CAMPING GUIDELINES**

- Campers\* at Purina Farms must have a pre-reserved site in one of two designated RV lots the Full-Service Lot behind the Purina Event Center or the Electric Only Main Show Field Lot - at Purina Farms. Sites can only be reserved for pull-behind trailers and motorhomes designed for overnight camping. Campers may not be parked in the regular vehicle parking lots.
  - Sites 45-47 in the Electric Only Main Show Field Lot are authorized access only as determined by Purina Farms management.
- Unless otherwise noted, campers may begin arriving at 3pm on their check-in day for an event. Campers must vacate
  their sites by 6pm on their check-out day.
- Any campers arriving before their scheduled times (or those arriving without a reservation) may be placed in a holding lot by security or may be asked to leave if accommodations are unable to made. Any campers placed in holding lots must vacate by 11 pm on the same day of arrival.
- Upon arrival at Purina Farms, campers must check-in with Purina Farms security at the front entrance gate to the
  property or call (636) 221-1428 to receive parking tags and camping information.
- Each camper will receive 3 parking tags good for one camper and 2 accompanying non-commercial vehicles (note that
  a tow vehicle would be considered one of the 2 accompanying vehicles). Accompanying vehicles may only be parked at
  the site when the site is occupied by the affiliated camper. The Full-Service Purina Event Center lot tags are red and the
  Electric Only Main Show Field Lot tags are yellow. Parking tags must be visible inside the vehicles at all times.
- A camper (only one camper unit per space), along with the 2 non-commercial vehicles, must fit within the size limits of
  each designated site. Campers and accompanying vehicles should not block roadways or they will be asked to move.
  If accompanying vehicles do not fit in the designated site, then they may be parked in the regular North parking lot in
  front of the building. Camper sizes must be accurately reported at the time of the reservation or risk being moved to a
  site more accommodating to the actual size of the camper.
- Quiet hours are between 11 pm and 6 am. Campers with reservations coming in after 11 pm will be directed to a holding lot by security so as not to disrupt other overnight guests.
- Purina Farms security regularly monitors the lots and is available on property 24/7.
- In case of a medical emergency in one of the lots, call Purina Farms security (see important contact numbers) or 911.
   A blue light emergency station is available on the South side of the Purina Event Center.
- Guests needing medical attention should leave their camper's lights on allowing the response team to easily identify the
  appropriate vehicle.
- Please notify a Purina Farms team member if you are having any difficulties with the hook-ups, including electric. Call security if you can't locate Purina Farms management.
- A camper MUST be checked on regularly if dogs are left unattended inside and there MUST be a reliable means to
  monitor the temperature in the vehicle. Purina reserves the right to remove any animals in distress from the vehicle.
- Other general items to note:
  - No parking on grass.
  - No tent camping.
  - Small group gatherings are acceptable in the RV lots not to exceed 10 guests. Parties are prohibited: Larger
    group gatherings require a contractual agreement for a rented space on property.
  - All dogs must remain on leash and supervised unless inside a vehicle or competing.
  - No pine shavings on any grass around the property.
  - Motorized vehicles, which includes golf carts, are not allowed except (i) when a medical condition or disability
    requires the use of one, or (ii) prior authorization is obtained from Purina Farms management and event organizers.
  - Propane and charcoal grilling are permitted in the lots. Guests should let the coals burn out overnight, bag them the next day and put them in a trash barrel.
  - Open fires, including fire pits, are not allowed on the property.
  - Free WiFi is provided under our "guest network" and no password is required. The expectation is that each camper will abide by acceptable use guidelines in order to continue to have access to this resource.
- Any false or inaccurate information provided when booking a reservation will result in the reservation being null and void with no refunds given.



- RV reservations are only accepted for those entered in an event that has contracted space which includes the
  overnight camping lots. Upon request, participants must be prepared to show proof of event entry upon arrival at
  Purina Farms.

Purina Farms reserves the right to ask any camper or accompanying vehicle occupant(s) without appropriate documentation, or those in violation of these guidelines, to leave the property. Unauthorized vehicles may be towed without further notice and at the owner's expense.

# INCLEMENT WEATHER

In the event a severe weather or tornado warning is issued for the immediate area, Site Security will notify the Purina Farms management team. The team will notify guests of an impending weather event via the property-wide public address system. Public service announcements should also come via the storm siren and announcements. Guests will be asked to seek cover in designated areas marked as severe weather shelter areas inside the Purina Farms facilities (those in the outdoor event areas should seek cover in one of the indoor facilities on the property). Areas at the Purina Event Center include the Gateway Hall, restrooms, South stairwell and the Great Hall if necessary. At the Visitor Center, this includes the bathrooms, indoor theater and the hallway near the front information desk. After the weather event ends, Purina Farms management teams will announce all clear.

- If weather is extreme after-hours, then security will unlock the Purina Event Center to allow overnight guests to
  come into the building with dogs at any time. The service center is also open 24/7 for campers to seek shelter.
- Should the weather look threatening, Purina Farms Security will go around the lots to notify overnight guests to seek shelter. Security will also visit the outdoor event areas around the property to let guests know there is threat.

# PURINA FARMS

#### **Property Access and Building Hours**

- o The front Purina Farms entrance/exit gate is manned daily by a security guard from 6a.m. 6p.m. to allow access to the property. Gates may be closed outside of these hours, but access to and from the property is still possible by pushing a call button at the gate or calling security at 636-221-1428 or 314-982-2217. The exit gate automatically opens to allow guests to leave.
- Regular Purina Event Center building hours are 6a.m 6p.m. unless otherwise posted.

#### Clean-up

- Guests are responsible for cleaning up after their dogs. This includes properly disposing of waste and using designated relief areas and the public x-pen area on the East side of the Gateway Hall for all elimination needs.
- Designated stations throughout the facility should be used appropriately (i.e. watering station should not be used for waste or other materials and bathing tubs should not be used for cleaning crates.)

#### Grooming

- o 20 amps of electric service available per assigned space inside the facility.
- All grooming in The Great Hall must be on 4mil plastic that covers the floor.
- Rubber caps for the tables are available if tables appear they will damage the flooring.

#### Food and Beverage

- Need to be purchased through the on-site food service and catering company.
- No outside food or beverage, or outside food service/catering company, is allowed on the Purina Farms property (unless organization receives written permission from Purina Farms management).
- Any violation will be reported to the AKC or the appropriate sanctioning entity of the event.

#### Dogs

- No dogs are allowed, except for service dogs: in the Checkerboard Café, on the second floor of the Purina Event Center (unless given prior permission) and in any restroom or human bathing area.
- All dogs are required to be on-leash at Purina Farms at all times (except when crated or as required to be judged.)
- o No swimming (dogs and people) allowed in any ponds on the property.
- o No dogs should be left unattended in the off-leash exercise areas or the public outdoor x-pens around the

#### Parking

- No parking in the following areas: Fire lanes, inside either Hall (No vehicles are allowed to drive inside either hall) or on the sidewalks leading into either Hall except where loading and unloading is designated. In addition, no driving is allowed on sidewalks.
- o Driving or parking on any grass at Purina Farms is prohibited.
- All guests must abide by the 15-minute unloading/loading parking time limit designated around the Purina Event Center.


#### Supplies

#### General

- No helium balloons in either hall. Balloons can be used in the Founder's Room (with approval from Purina Farms management). No glitter, confetti or candles allowed.
- Public intoxication is prohibited at Purina Farms.
- No exercise pens allowed around the front and back of the Purina Event Center or the grassy area adjacent to the East side of the Gateway Hall. Overall, exercise pens around the perimeter of the entire building are strongly discouraged. Any exercise pens on designated grassy areas should not have a flooring/covering to prevent damage to the grass.
- o Shavings may not be used on any grass around Purina Farms.
- Children must be supervised and accompanied by an adult at all times when on the grounds (including the Purina Farms Visitor Center and especially on the balcony at the Purina Event Center).
- Guests accept personal liability with respect to any claim made in respect to any damage or injury caused by their dogs or dogs in their possession.
- Smoking, including the use of electronic cigarettes, is prohibited in buildings.
- Weapons of any kind, illegal drugs and fireworks are not permitted on the premises.
