GENERATIONS

This Non-Regular Class is offered to all three-generation families with one exhibit from each generation regardless of sex exhibited with the oldest to the youngest. ONLY ONE OF THE DOGS ENTERS and PAYS THE ENTRY FEE. All neutered and spayed AKC registered Norwegian Elkhounds are eligible. Placing will be FIRST through FOURTH. It is judged much like the Stud Dog and Brood Bitch, except that the merits of all three generations are considered. The three Elkhounds comprising each entry must make up a three-generation pedigree. Entry is made for each dog (three separate entry forms) and all entries must be submitted together

For example: Dog #1 - A Father or Mother
Dog #2 - A Son or Daughter
Dog #3 - A Son or Daughter of Dog #2 and a Grandson or
Granddaughter of Dog #1

Prize Money

35% of the entry will be retained by the club for expenses. The remainder balance will be divided as follows:

First place 45%, Second place 25%, Third place 20% and Fourth place 10%.

Rosette will be awarded for first place and ribbons for second through fourth

Dogs that have earned an AKC Championship CAN enter Sweepstakes. Professional handlers are not allowed to exhibit in the Sweepstakes classes.

SWEEPSTAKES (Sunday Only)

Puppy Sweepstakes

Puppy Sweepstakes is open to all Norwegian Elkhounds who on the day of the show will be 6 months and under 24 months of age. Each entry for the sweepstakes must be entered in a regular class at this show.

Puppy Dog or Bitch, 6 mos & under 9 mos
Puppy Dog or Bitch, 9 mos & under 12 mos
Puppy Dog or Bitch, 12 mos & under 18 mos

Distribution of Puppy Sweepstakes Prize Money

35% OF TOTAL ENTRY FEES WILL BE RETAINED BY Club for expenses. The remainder of the monies received from entry fees shall be awarded to the class winners on a proportional basis as follows: 50% to be divided amount first place winners. The remaining 50% of the fee divided 60% to Best Puppy in Sweepstakes and 40% to Best of Opposite Sex to Best Puppy in Sweepstakes

Veteran Sweepstakes

Veteran Sweepstakes is open to all Norwegian Elkhounds who are at least 7 years of age on the day of the Sweepstakes. Entrants may be altered and need not be entered in a regular class. Only one winner from each class will be chosen. There is no competition between the sexes. From the class winners a Best Veteran Dog in Sweepstakes and Best Veteran Bitch in Sweepstakes will be chosen.

Dogs or Bitches 7 yrs & under 9 yrs.
Dogs or Bitches 9 yrs & under 11 yrs
Dogs or Bitches 11 yrs & older

Distribution of Veteran Sweepstakes Prize Money

35% of total entry fees will be retained by Club for expenses. The division of entry fees will be an equal split between Best Dog and Best Bitch in Veteran Sweepstakes. Best Veteran Dog 50% & Best Veteran Bitch 50%.

Best Veteran Dog and Best Veteran Bitch will also receive a handcrafted dog related item.

All cash prizes rounded to nearest dollar amount. Undistributed funds revert back to Club. Class cash prizes will be paid in the ring to the person handling the dog. Claims for prize money must be made in the ring before the judging is over. NEINEA disclaims any liability for cash prizes after judging is over.
